The legislators engaged in a bi-partisan assessment of Florida's criminal justice system and ways in which adjustments and growth can be beneficial to all Floridians, including those with mental health concerns. ISPS offers opportunities for Floridians to engage in their communities and government and with each other. ISPS works to bridge-gaps between institutions and citizens and serve as a conduit between individuals, their government, and as a convener
